**Remote e-Voting:**  
 Pursuant to Section 108 of the Act read with Rule 20 of the Companies (Management and Administration) Rules, 2014, and Regulation 44 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, the Company is providing the facility of remote e-Voting before / during the AGM in respect of the business to be transacted as mentioned in the Notice of 17<sup>th</sup> AGM by engaging the services of MUFG Intime India Private Limited.
