Public complain of delay in issuance of driving licence at Dindigul RTO

Appealing to the District Collector Durga Moorthy to intervene into the issues pertaining to issuance of driving licence to the learners through the Regional Transport Office (RTO) Dindigul, the public said that they have been waiting for the last three months for no fault of their own.

A large number of public and office-bearers from the Dindigul District Driving School Owners Association led by its president C. Suresh Kumar said that the automated testing tracks at the Dindigul RTO had not been functional and posed hardships to the candidates. A majority of them also faced dangerous situation while undergoing the testing tracks.

"Even qualified drivers may find it difficult and hence the testing tracks need to be recalibrated in such a way that it is functional and user friendly as in other RTOs," he added.

Some of the applicants said that they were waiting for almost three months due to the technical snag in the automated testing track. As a result, many of them have been deprived of job opportunities and overseas employment.

An official at the RTO Dindigul said that they had no control over the tracking system or in awarding pass/fail. The entire system is being handled by a private agency, outsourced by the Tamil Nadu government.

Despite representations made to the higher officials in the Transport Department, they have not addressed the issue yet, he said requesting anonymity.

However, the Collector soon and examine the difficulties to sort out the issue amicably.

Prime accused in schoolboy's murder escapes

The accused, Aravind, who was lodged in Madurai Central Prison, escaped from police custody while returning from court hearing

Aravind, the prime accused in the case of sexual assault and murder of a Class X student near Tirupathur in Sivaganga district, escaped from police custody on Tuesday while being returned to prison after a court appearance.

Aravind, 24, from Ilan-thaimangalam in the district, who had already been detained under the Goondas Act in Prison, Madurai Central Prison, had been taken to the Sivaganga court for a hearing. According to the police, he was transported on a two-wheeler instead of a standard prison van.

He escaped by showing the escort police personnel when the vehicle was stopped at the traffic signal near Yanakkal Junction in Madurai. He fled into the crowds.

Subsequently, Vilakkuthon police have registered a case, and a search is on to trace the accused. Aravind had earlier been arrested by Sivaganga District police, along with a 17-year-old accomplice, for the sexual assault and murder of a Class X boy, whose body was discovered with a slit throat near Keel Kavanor irrigation tank on June 5.

Investigators revealed that Aravind had been in a relationship with the victim, and the two suspects

plotted the murder after the boy allegedly disclosed their relationship to others.

According to the police, the perpetrators consumed liquor with the victim just prior to the attack. The breakthrough in the case came when an eyewitness stepped forward to report the crime.

Acting on a complaint from victim's father, Keelasevalpatti police registered a case under Section 103(a) of the Bharatiya Nyaya Sanhita, besides relevant provisions of the POCSO Act. Following his arrest, Aravind was remanded in Madurai Central Prison, while the minor accomplice was sent to a government observation home.

Armed gang kills construction worker near Tiruchuli

N. Akash, 26, a construction worker at Senthanthi near Tiruchuli police station limits, was murdered by an armed gang on Monday.

Police investigation on Tuesday suggested that

Akash had previous enmity with Murugan. For sometime, Murugan, it is alleged, had planned to retaliate Akash.

On Monday, when he was riding his bike from Tiruchuli-Kamudi Road, he was intercepted by a gang at Panayur.

Within a few minutes,

the gang, attacked him with knives and other sharp weapons, killing him.

On information from Akash's wife, the Tiruchuli police registered a case and arrested six persons, including Vijay, 26, Ritesh, 24, Kalidas, 21, and Murali, 27.

Two men surrender in murder case

Claiming to have murdered a man, two persons surrendered before the Dindigul Taluk Police on Monday. After searching for the victim's body for almost five hours, the police recovered it from a secluded water body and sent it to the Government Hospital for post-mortem.

Police said that the vic-

tim was identified as Karanraj. The reason for the murder was unknown as the two suspects who had surrendered did not cooperate in confession.

A senior officer said that the victim was murdered and the body was abandoned in the tank. Since the hands and legs were tied, the post-mortem details may divulge about the injuries and other information, he added.

Consider representation made by Sri Lankan Tamil refugee: HC

The Madurai Bench of the Madras High Court on Tuesday directed the Tirunadhagar Collector to consider a representation made by a Sri Lankan Tamil refugee who sought adequate compensation for the death of his 11-year-old daughter. The girl fell ill after drinking contaminated water in the Sri Lankan refugee camp in Sivakasi.

The court was hearing a petition filed by T. Nathan who is residing at the Sri Lankan Tamil Rehabilitation Camp in Sivakasi. He said the camp currently houses around 38 families. The residents are engaged in daily wage labour, painting work and other forms

of unorganised employment.

He said they depended on the water supply provided in the camp for drinking and domestic requirements. He alleged that a bore well meant to supply drinking water was constructed at a location between three pre-existing septic tanks. The people had raised objections.

Effluents and biological waste from the septic tanks gradually percolated into and mixed with the groundwater drawn rendering the water supplied to the camp unfit for human consumption.

Having no other alternative source, they continued to draw and consume the contaminated water for drinking, cooking and other domestic purposes. As a

result, several residents of the camp, including children, developed high fever and were admitted to the Government Hospital in Sivakasi. One among them was his daughter N. Nijasthana, he said.

She was shifted to the Government Hospital in Tirunadhagar for further treatment. However, she died the next day. The tragic death had caused widespread outrage among the residents of the camp who staged a protest demanding accountability.

He sought a direction to the authorities to test the drinking water source in the camp, conduct an inquiry and pay compensation. Justice C. Saravanan directed the Collector to consider the representation made by petitioner.
