The eligibility marks of 55% marks (or an equivalent grade in a point scale wherever the grading system is followed) and the relaxation of 5% to the categories mentioned above are permissible, based only on the qualifying marks without including and grace mark procedure.
- A relaxation of 5% shall be provided, (from 55% to 50% of the marks) to the Ph.D Degree holders who have obtained their Master's Degree prior to 19th September, 1991
- A relevant grade which is regarded as equivalent of 55%, where ever the grading system is followed by a recognized university, at the Master's level shall also be considered valid.
- For the open post candidates from backward classes as well as physically challenged persons can also apply.
- The reservation for women and physically challenged persons shall be as per then Govt. of Maharashtra rule.
