18-year-old girl dies due to overdose of synthetic drug

An 18-year-old girl died here on Monday allegedly due to an excess dose of synthetic drug injected by her boyfriend.

According to police, a couple, who claimed to be married, stayed in a hotel near the railway junction. Both of them had taken the drugs. The girl was said to have developed epilepsy. Her boyfriend with the help of his friend took her to Mahatma Gandhi Memorial Government Hospital, where the doctors declared her dead.

Police recovered syringes and drugs and suspect it to be a case of drug overdose. A case was registered and two persons, aged 19, belonging to Ariyamangalam, were taken into custody for questioning.

An undue delay in starting the construction of a road overbridge (RoB) at Kulithalai on the Musiri-Manappalai Highway has irked the commuters.

The highway, which caters to the commuters travelling between Kulithalai in Karur district and Manapparai in Tiruchi district, was not a busy road until 10 years ago. Young tetanus patient treated at MGMGH

Doctors at the Pediatric Emergency Department of the Mahatma Gandhi Memorial Government Hospital (MGMGH) in Tiruchi saved the life of a critically ill five-year-old boy suffering from tetanus.

The boy was admitted to MGMGH on May 3 with continuous muscle contractions and breathlessness caused by tetanus. The disease is a serious, potentially fatal bacterial infection caused by *Clostridium tetani*. After a dedicated treatment programme at the hospital, the patient showed complete recovery and was discharged on Tuesday, according to an official press release.

Doctors advised parents to ensure that their children received their primary anti-tetanus vaccines.
