

Rakkaskoppa reservoir reaches full capacity, brings much-needed relief

FOLLOWING heavy rainfall in the Western Ghats and the Tillari region, the Rakkaskoppa Reservoir has reached its full capacity, bringing much-needed relief to Belagavi city. Belagavi City Corporation (BCC) Commissioner Karthik M. visited the reservoir to inspect the water level, inflow, outflow, and overall storage capacity.

Belagavi primarily depends on the Rakkaskoppa Reservoir for its drinking water supply. Earlier this year, a weak monsoon had left the reservoir almost dry, leading to severe water shortages across the city. To address the crisis, the BCC had made alternative arrangements for drinking water supply. With the region now receiving 40-50 mm of rainfall daily, the reservoir has filled up completely, rais-

ing hopes among residents for a stable water supply.

Speaking after the inspection, Commissioner Karthik M. said that drinking water is currently be-

ing supplied to the city from both the Rakkaskoppa and Hidkal reservoirs. He noted that 10 wards already have a 24x7 water supply system. During the water scarcity,

these wards had received water for only two hours once every two to three days. With the reservoir now full, uninterrupted 24-hour water supply will be restored in these areas. In the remaining 48 wards, where water was supplied only once every 8 to 10 days during the summer, the supply has now improved to once every two to three days. The Commissioner added that the Rakkaskoppa Reservoir, with a full reservoir level (FRL) of 2,475 feet, has reached its maximum capacity. Together, the Rakkaskoppa and Hidkal reservoirs are supplying 105 million litres per day (MLD) of drinking water to Belagavi, and the current storage is expected to meet the city's water needs until May, with no major shortages anticipated. Officials from KUDFC, along with municipal officers and staff, were present during the inspection.

Bhangi community seeks property documents, electricity for poor families residing for 40 years

Belagavi: A memorandum was submitted to the Chief Executive Officer (CEO) of the Belagavi Zilla Panchayat, urging authorities to provide necessary property documents (Utara) and basic civic facilities to poor families residing in Khanapur town. According to the representation submitted by the residents, several families belonging to the Bhangi community have been residing for more than 40 years near the well at 3rd Cross Road in Dindi Nagar, Ward No. 2, Khanapur. The petitioners alleged that despite their long-term residence, the families have not been provided with the required property records through the Halkarni Gram Panchayat. The petitioners stated that the families are economically disadvantaged and that other local residents have already obtained property documents through the gram panchayat.
