

# Dharmasthala row: BJP demands CBI probe

STATE BJP leaders urged Chief Minister DK Shivakumar to order a Central Bureau of Investigation (CBI) probe into the alleged conspiracy targeted at Dharmasthala and Dharmadhikari D Veerendra Heggade.

BJP MLC CT Ravi has written to the State Government to hand over the case to the CBI for a comprehensive and impartial investigation. "As this issue concerns the faith of millions of devotees, religious sentiments, and public trust, I urge the government to treat the

matter with utmost seriousness and immediately recommend a CBI investigation" he urged.

According to him, the institution has set a national example through its contributions in social service, education, healthcare and mass-feeding programmes. "Over the past few years, however, the people of Karnataka have witnessed a continuous targeting, allegations, propaganda and an atmosphere of suspicion being created against both the institution and Veerendra Heggade."

He said the recent high court petition has given a serious and

new dimension to the matter. "According to media reports, the petition names several individuals, including actor Prakash Raj, Mahesh Shetty Timarodi, Girish Mattannavar, Vitthal Gowda, Jayanth, and YouTubers Sameer MD and others. Now a serious allegation has been made before the court that an organised and systematic conspiracy costing nearly Rs 200 crore was planned against Dharmasthala and also Heggade. Whether these allegations are true or false must be determined through a proper investigation," he said.

Ravi also questioned the source of the money.

## CHINNA ACCUSES MATTANNAVAR, YOUTUBER OF INTIMIDATING HIS FAMILY MEMBERS

Mangaluru: THE Complainant in the alleged Dharmasthala burial case, Chinna CN, visited the office of the Special Investigation Team (SIT) in Belthangady, Dakshina Kannada, and the Dharmasthala police station on Monday and filed a complaint seeking action against Girish Mattannavar and a YouTuber for allegedly attempting to intimidate his family. In the complaint, Chinna, a former sanitation worker in Dharmasthala, alleged that after he filed a writ petition in the High Court of Karnataka, Mattannavar and others allegedly contacted his family members with the intention of derailing the ongoing probe, influencing the witnesses, and attempting to meet him. "On June 12, a YouTuber named Abhishek contacted my relative Purushitham and asked about the writ petition. He kept asking who is behind the writ petition. He also asked to provide my contact number and wished to talk to me. He also tried to collect information about my family. He indirectly attempted to intimidate and pressurise," Chinna stated in the complaint. He further alleged that on the same night, Mattannavar contacted his wife's sister's son, Ravi, and attempted to collect information about the writ petition. **ENS**

# Indira Lankesh no more

INDIRA Lankesh (84), writer and the wife of noted Kannada litterateur, journalist and Lankesh Patrike founder P Lankesh, passed away on Monday morning due to age-related ailments.

Known for her close association with Karnataka's literary and journalistic circles, **Indira Lankesh** had authored the memoir 'Huli Maavu Mattu Naanu' (The Tamarind Tree and I), reflecting on her life and experiences. She is survived by her son Indrajit Lankesh and daughter Kavitha Lankesh, both filmmakers. Her elder daughter Gauri Lankesh, a journalist,



was shot dead in 2017.

Chief Minister DK Shivakumar, condoling her death, said, "Indira Lankesh was the backbone of P Lankesh's achievements in literature, media and the film world. Alongside that, she had immersed herself in business, writing and book publishing. Having lived a life with the unyielding determination of a rock that never gave up its resolve, Indira Lankesh was an inspiration to all girls and women."

Deputy CM G Parameshwara also condoled her death, saying Kannada literature and journalism lost another vital pillar whose contributions to literature, social thought and public life will not disappear from people's memories.
