Students brave incessant rain to join nationwide protest over NEET

BRAVING persistent rain, a large number of students and school-children gathered at Rani Channamma Circle on Thursday, joining the nationwide protests over the alleged NEET paper leak and demanding accountability, transparency and reforms to protect the integrity of competitive examinations.

The youth-led demonstration began around 11 am and contin-

ued until nearly 2 pm, with participants remaining at the venue despite the downpour. Waving the Indian tricolour and carrying placards and banners, students filled the area with patriotic songs and chants of 'Vande Mataram' and 'Inquilab Zindabad', underscoring what organisers described as a movement to defend merit and fairness in education.

The protest echoed demands being raised across the country, including the resignation of Un-

ion Education Minister Dharmendra Pradhan, a time-bound and transparent investigation into the alleged NEET paper leak, stringent action against those responsible and ₹1 crore compensation for the families of students who allegedly lost their lives in connection with the controversy. Protesters also condemned the police action against students during demonstrations in Delhi on July 20, describing it as unconstitutional.

Addressing the gathering, a

protester urged those who had successfully cleared the examination to stand in solidarity with fellow aspirants affected by the controversy, saying the issue extended beyond individual success and concerned the credibility of the country's examination system. Another student expressed frustration over what participants described as the government's lack of accountability, arguing that students deserved clear answers and swift action.

5-yr-old B'gavi girl is world's youngest TEDx speaker

BELAGAVI has earned global recognition with five-year-old Aarna S Jeevangunder, a student of Birla International School, creating history by entering the Guinness World Records as the World's Youngest TEDx Speaker. She achieved the remarkable feat at the age of just 4 years and 287 days, making her one of the youngest inspirational speakers on a global platform.

The official Guinness World Records certificate was presented to Aarna by Belagavi Deputy Commissioner Mohammad Roshan in recognition of her outstanding achievement.

Aarna delivered her record-breaking TEDx talk during the official TEDx event held at the Foundry Cluster in Belagavi on August 30, 2025. Speaking on the theme "No Boundaries for Learning," she inspired the au-

dience by sharing her learning journey and highlighting the importance of curiosity, creativity, and self-belief. Her message emphasized that passion and a positive mindset can help children achieve extraordinary success regardless of age.

Apart from the Guinness World Record, Aarna is also a two-time India Book of Records holder. She has been recognised

as the Youngest TEDx Speaker from India and for flawlessly reciting all Indian national symbols within just 30 seconds.

Her parents credited Birla International School for nurturing talent beyond academics and expressed special gratitude to Manjeet and Lakshmi Khilari for their constant encouragement and guidance.

Congress govt cancelled over 1,300 PMAY houses in Belagavi South: MLA

Belagavi: BJP leader and Belagavi South MLA Abhay Patil has levelled serious allegations against the state government, claiming that it has cancelled more than 1,300 houses sanctioned under the Pradhan Mantri Awas Yojana (PMAY) in the Belagavi South Assembly constituency. Addressing the media here on Thursday, Patil described the Congress government as 'anti-people' and accused it of depriving economically weaker sections of their rightful housing benefits. Patil said that during the BJP government's tenure, a total of 1,748 houses were sanctioned under the PMAY for beneficiaries in Belagavi South constituency. Of these, construction of around 450 houses had already begun and was progressing. However, he alleged that after the Congress assumed office, the remaining 1,300 sanctioned houses were cancelled, leaving hundreds of deserving families without a permanent home. "The Congress government has not only failed to sanction new houses for the poor but has also scrapped the houses that had already been approved by the previous government," he added. He further claimed that under the PMAY, nearly 1,500 houses are generally sanctioned every year for eligible beneficiaries in the constituency. Based on this norm, Belagavi South should have received around 4,500 new houses over the last four years. "Instead of continuing the scheme and ensuring housing for the poor, the Congress government has denied fresh allocations and cancelled previously sanctioned houses. This is a grave injustice to the underprivileged," he said.
