Several regions in Kodagu receive heavy rainfall

THE taluk tahsildars have declared a holiday on Saturday for schools and colleges in Madikeri and Somwarpet following continuous and heavy rainfall. Several regions in the district recorded heavy rainfall on Friday, affecting normalcy.

Madikeri has been receiving heavy and continuous rainfall for the past three days. A minor landslide was reported on the outskirts of the city at Mangaladevi Nagar, instilling fear among the residents. Madikeri

and Somwarpet taluks are recording continuous rainfall and several roads have been waterlogged due to neglected, overflowing drains. A KSRTC Bus plying on the Bhagamandala-Madikeri route toppled after the driver lost control of the vehicle on the curvy road. However, no injuries were reported.

Following continuous and heavy rainfall on Friday, the tahsildars of Madikeri and Somwarpet taluks declared a holiday for schools on Saturday. Several trees and electric poles were uprooted in the heavy downpour.

COURT DENIES ANTICIPATORY BAIL TO ABSCONDING ADLR

Hussain absconding nearly for a month after being booked for allegedly appointing a plp person as data entry operator

THE Third Additional District and Sessions Judge, Mandya, rejected the anticipatory bail plea of Assistant Director of Land Records (ADLR), Mohammed Hussain, Srirangapatna.

Hussain has been absconding nearly for a month after he was booked for allegedly appointing a private person, Nithin Padmanabha Mahale, as a Data Entry Operator (DEO) illegally. He also shared his username, ID and password,

unauthorised digitising Aakar-Band in 'mojani' entries in the software of the state government.

"Appointing a person as DEO in a government department and doing illegal transactions to create fake documents is really a terror to society at large. It is a white collar crime, observed Judge Jyothsna D while refusing to grant anticipatory bail to Hussain.

The judge also dismissed the bail applications filed by eight accused attached to the office of Hussain. They are Survey

Supervisor Yogaraju A L, Surveyors Aravinda B N, Madhu Y B, Jayaboregowda, Dayananda A S, Ramesha B, Harisha and Nesha Sarika Malli.

"If these accused are released on bail, there is a chance of them hampering the prosecution witnesses and tampering with the prosecution evidence. Seventy-one persons have transferred money to Mahale

through PhonePay. They misused Mojani Software which casts a shadow of offence under the Information Technology Act and also cyber-crime", Judge Jyothsna noted, pointing out that no one will transfer such a huge amount to his account without any reason.

On the contention of Hussain that Mahale was not appointed by either the govern-

ment or any authorised department, the court noted that anyone can know that in a government office without leave of the government, nobody shall be appointed as a government servant. The fake seals, created documents and forged signatures of authorities were recovered from the house of Mahale, where Hussain was also residing. Even prior to the transfer of Hussain to Srirangapatna, it was stated that Mahale was working with him in Hunsur, Kolar taluk and Sakleshpur taluk.

Youth found murdered near rly stn in C'ballapur

A 28-year-old youth was found murdered near the railway station under the jurisdiction of the Chikkaballapur Town Police Station in the early hours of Friday. According to SP Kushal Chouksey, the deceased has been identified as Habib Pasha, a painter and a resident of TG Tank Road, Chikkaballapur. The SP said the police rushed to the spot around 2am after receiving information about the incident. Habib was found lying in a pool of blood. Preliminary investigations indicate that the assailants crushed his head with a large stone, resulting in his death.

Two special teams have been formed under the direct supervision of the SP to trace the evidence. The police are examining the CCTV footage from the surrounding area and questioning the victim's associates as well as local residents as part of the investigation.
