Elaborate steps in place to ensure smooth darshan

ALL necessary arrangements have been made to ensure smooth darshan of Goddess Sri Chamundeshwari during the Ashada Fridays and Chamundeshwari Vardhanti celebrations atop Chamundi Hills.

Chairing a preparatory meeting atop Chamundi Hills here on Tuesday, Deputy Commissioner G Lakshmikantha Reddy said the four Ashada Fridays will be observed on July 17, 24, July 31, and August 7, while Chamundeswari Vardhanti (Ammanavara Janmotsava) will be celebrated on August 4.

KSRTC will operate special bus services from Lalitha Mahal Helipad and the KSRTC City Bus Stand from 6.30 am to 8.30 pm on all the four Ashada Fridays as well as the following Saturdays and Sundays. Devotees climbing the hill on foot will be allowed to begin their ascent only after 5 am, and the public has been advised not to gather before the permitted time.

No stand for footwear

The DC clarified that there will be no footwear stand at Chamundi Hills. Instead, footwear counters have been arranged at Lalitha Mahal helipad and the KSRTC City Bus Stand, and devotees have been requested

to make use of these facilities.

Protocol dignitaries and VIPs will be permitted to have darshan only between 5.30 am and 10 am. Entry of all protocol vehicles to Chamundi Hills will be prohibited after 10 am.

Entry of private vehicles to Chamundi Hills will remain completely prohibited on all Ashada Fridays and on the day of Chamundeshwari Vardhanti. Only vehicles carrying valid duty passes will be allowed.

Control room to monitor devotee movement

A dedicated control room will be set up to monitor general and ₹2,000 special darshan queues and ensure smooth crowd management. The control room will be manned by the Mysuru City Police Deputy Commissioner, the KSRTC City Divisional Controller and the secretary of the Chamundeshwari Area Development Authority.

Officials have been instructed to prevent overcrowding in queues and ensure that only ticket holders enter the ₹2,000 special darshan queue. Display boards indicating the estimated waiting time for darshan will also be installed to keep devotees informed.

The DC also directed officials to provide adequate mobile toilets, dustbins and drinking water facilities at key locations.

GTD's son-in-law booked for posting objectionable comment on kin

THE police have identified the accused involved in alleged objectionable social media comment targeting Varsha Gowda, wife of Hunsur MLA G D Harish Gowda. It turned out to be Vishweshwarai-ah, son-in-law of former minister and senior JDS leader G T Devegowda, bringing the family dispute to limelight again.

A case was registered after Varsha lodged a complaint at the Cyber, Economic and Narcotics (CEN) police station alleging that derogatory remarks had been posted against her on social media. During the course of the investigation, police traced the account and identified Vishweshwaralah as the accused.

Speaking to reporters, the complainant said the police probe revealed that the IP address has been traced to mobile and gmail accounts used in Wilson Garden in Bengaluru which belonged to Vishweshwaraiiah, who according to police have been served notice to come for the investigation.

Reacting to the development, MLA Harish Gowda urged people to exercise restraint while using social media. "There is nothing wrong with expressing opinions or making comments in a healthy and competitive manner. However, social media should not be

used to defame, insult or tarnish the image of any individual," he said. The MLA also expressed disappointment over the involvement of a close family member in the incident.

The episode has drawn attention in political circles, as Harish Gowda has reportedly been estranged from his father, G T Devewgowa, for the past few years. The alleged offence is being viewed against the backdrop of the reported rift within the family, though police have not officially commented on any motive behind the act. Vishweshwaraiah is the husband of Devewgowa's elder daughter.

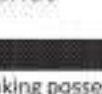
