Sakrebailu Elephant Camp to reopen before August 15

The camp has been closed following the death of a visitor at Dubare

THE Sakrebailu elephant camp, located about 14 km from Shivamogga city, is set to reopen to the public before August 15, 2026, with strict safety measures and standard operating procedures (SoPs) in place.

The camp has been closed for over a month-and-a-half, following the death of a woman visitor from Chennai at the Dubare Elephant Camp on May 18, 2026. In the wake of the tragedy, the state government ordered the closure of all 14 elephant training camps across Karnataka from May 21, prohibiting visitor entry. Deputy Conservator of Forests (Wildlife) Prasanna Pattagar confirmed the reopening timeline to *The New Indian Express*. However, he made it clear that visitors will have to strictly adhere to government norms. "As per the rules, the public will not be allowed near the elephants," he stated.

Prior to its closure, Sakrebailu Elephant Camp, situated on the banks of the Tunga reservoir's backwaters, was one of the most popular tourist destinations in Shivamogga district. Visitors would throng the camp to watch mahouts and kavadis bathing the elephants. According to department sources, weekend footfall ranged between 5,000 and 10,000 visitors, while summer and Dasara holidays typically drew around 3,000 people daily. In the 2025-26 fiscal year, the

camp recorded 2.70 lakh visitors, generating Rs 1.8 crore in entrance fee revenue. Now, with the reopening on the horizon, the Forest Department has introduced a stringent set of precautionary measures to prevent any untoward incidents. As per the new SoPs: Visitors are strictly prohibited from feeding, touching, or bathing the elephants. Taking selfies near the elephants is banned. A mandatory safety distance of 10 metres must be maintained. Three designated zones, Red, Orange, and Green, have been created, with visitors permitted only up to the Orange zone for viewing.

The department has also restricted its own staff and officials through the SoPs, which cover protocols such as the number of elephants to be brought to the camp site, visitor capacity limits, and the installation of CCTV cameras for surveillance. Once these measures are fully implemented, the local forest authorities must obtain final approval from the Chief Forest Conservator (Wildlife) in Bengaluru before allowing visitors. "As per the SoP norms, the department will permit visitors at the Sakrebailu elephant camp, and it will be open before August 15," Pattagar assured.

TIME LIMIT WAIVER

Confusion mounts over restoration of cancelled BPL ration cards

CONFUSION has gripped the public regarding the process of restoring Below Poverty Line (BPL) ration cards that were recently converted to Above Poverty Line (APL) status. Citizens are flocking to Karnataka One, Grama One, and Common Service Centres (CSC) across the district, seeking clarity on how to reapply for their cancelled BPL cards.

This surge in inquiries follows the Food and Civil Supplies Department's recent conversion of 13,641 BPL cards to APL. The action was taken against cardholders who failed to comply with eligibility norms, which include being an income tax payer, having an annual income above Rs 1.20 lakh, owning land exceeding seven acres, not collecting ration for over six months, or being registered for GST.

Amid the confusion, Deputy Director of Food and Civil Supplies Satish D clarified the procedure. "Those whose cards were converted to APL should submit a formal application and request letter to the tahsildar or the city's food inspectors," he told *The New Indian Express*. "Applicants must attach supporting documents, such as income certificates, to prove their poverty status," he claimed.

While the government initially mandated that reapplications be filed within 45 days of cancellation, this deadline has now been removed. However, officials stressed that restoration is not automatic. A field verification will be conducted. "After receiving the request letter, our officials will strictly visit the applicant's house, conduct an inspection of their financial status, and only then issue the cards," the DD added.

CSC operators have reported that many citizens are visiting their centres asking if they can complete the process online, following the announcement by District Guarantee Schemes Implementation Authority chairman C S Chandrabhoopal that the time limit had been waived.

According to the department, there are currently 4,96,700 active ration cards in the district.

Every citizen should act as a 'soldier' to protect forests: Judge

PRINCIPAL District and Sessions Judge Manjunath G A urged citizens to take responsibility for protecting forests, saying every person should act as an "internal soldier" for environmental conservation, just as soldiers defend the nation's borders.

Addressing the gathering after inaugurating the Afforestation and Lake Rejuvenation Campaign-2026 at the Government Women's Polytechnic College here on Tuesday, Manjunath said conserving forests and water resources has become an urgent priority to maintain ecological balance and ensure future generations have access to clean air and water.

The programme was organised jointly by the Karnataka State Legal Services Authority, District Legal Services Authority, District Judiciary, District Administration, Zilla Panchayat, Forest Department and the Government Women's Polytechnic College. "Just as soldiers protect the country's borders, every citizen must protect forests within the

country," Manjunath said. He urged students to develop environmental awareness from an early age and take ownership of conserving trees, forests and rivers.

He said environmental degradation and pollution are threatening public health and stressed that protecting natural resources is a shared responsibility.

Manjunath said the Karnataka State Legal Services Authority, in coordination with the Forest Department, is conducting large-scale plantation drives across the state. He added that the responsibility does

not end with planting saplings and that the authority will ensure they are nurtured for the next five years until they mature into trees.

Chief Conservator of Forests Dr K T Hanumanthappa said lake conservation and afforestation should be prioritised, describing clean water, pollution-free air and a healthy environment as essential for human well-being. Recalling his time in Delhi, he said the comparatively cleaner environment in the region should be preserved through sustained conservation efforts.
