

Will raise S'mogga HC circuit bench demand with Centre: BYR

'Justice ought to be within reach for all citizens without forcing them to travel long distances'

MP B Y Raghavendra said on Tuesday that he would take up the proposal to establish a High Court circuit bench in Shivamogga with the Ministry of Law and Justice, while assuring that he would vigorously pursue the demand at the national level. He also urged the State government to take the necessary steps to advance the proposal.

Backing the ongoing agitation by the District Bar Association on the premises of the District Court, Raghavendra said the demand was not confined to inaugurating an additional office, but was aimed at securing more convenient access to justice for residents of Malnad and Central Karnataka. He argued that justice ought to be within reach for all citizens without compelling them to travel long distances for even routine legal proceedings.

Noting Karnataka's geographical diversity, the MP said North Karnataka already has a High Court bench in Dharwad, while the Kalyana Karnataka region is served by a bench in Kalaburagi. However, he pointed out that people from Malnad and Central Karnataka continue to undertake journeys of

more than 300 kilometres to Bengaluru for legal matters, underscoring the need for a closer judicial setup.

Raghavendra said Shivamogga functions as a natural hub connecting districts including Chitradurga, Davanagere and Chikkamagaluru, making it an appropriate location for a High Court circuit bench to serve the region effectively. He further opposed proposals that would bring Shivamogga, Chikkamagaluru and Kodagu under the proposed Mangaluru High Court bench, citing significant geographical and logistical constraints.

He said those travelling from Shivamogga to Mangaluru

have to navigate routes through the Western Ghats, where landslides and road disruptions are common during monsoon months. He cited stretches through Agumbe, Hulikal, Shiradi and Charnadi ghats, and questioned the practicality of relocating access to justice away from the region's residents.

"Ordinary citizens should not be made to face such hardships in order to secure justice," he remarked. The MP also referred to opposition voiced by Bar Associations in Shivamogga, Hassan, Madikeri and Chikkamagaluru, which have submitted representations against the Mangaluru

proposal.

Calling upon the State government to act, Raghavendra said it should first put in place the required infrastructure, office facilities and financial support needed to establish the bench, secure approval from the Chief Justice, and thereafter submit the formal proposal to the Centre. He said he would then work with the Union government to obtain the necessary approvals once the prescribed process is completed.

Raghavendra urged advocates and the public to continue supporting the movement beyond political differences until a High Court circuit bench is established in Shivamogga.

BJP Raitha Morcha protests over farmers' pending demands in S'mogga

MP B Y Raghavendra on Tuesday participated in a protest meeting organised by the BJP Raitha Morcha at Shikaripura, alleging that the state government has failed to meet farmers' demands. A memorandum was submitted to the government through the Tahsildar's Office.

Raghavendra charged that the state government is pursuing policies that are inimical to farmers, calling them "condemnable." He said he would stand in solidarity with farmers for their welfare and continue to raise his voice against the injustices being inflicted upon the farming community.

The farmers have urged the state government to provide crop-loss compensation to the families affected by crop damage caused by untimely rains that lashed the district last month, insisting that the compensation be released strictly in accordance with government norms.

They also alleged that of the 46 rain gauge centres, more than 30 are not functioning due to the

negligence of officials. They claimed this has resulted in crop insurance not being implemented effectively, leaving farmers without the benefits they are entitled to. Farmers, they said, are still awaiting crores of rupees in crop insurance dues from the previous year, and the government must address the issue without further delay.

The farmers further demanded that the government ensure timely supply of seeds, fertilisers and insecticides ahead of the monsoon, well in advance, without postponements. They also called for the immediate resumption of distribution of agricultural implements as per the

submitted demands.

Highlighting another concern, farmers alleged that thousands of dairy farmers are yet to receive the milk incentive for the past six months. They urged the government to release the pending payments immediately, adding that many dairy farmers depend on this support for their livelihood.

The farmers also demanded that the government address difficulties being faced by farmers during the survey process and devise a practical solution to prevent farmers from being repeatedly asked to make unnecessary visits to the survey department.
