

# Potti walks out after bail in 2nd gold theft case

Relief for prime accused in Sabarimala case as SIT fails to file charge sheet in 90 days

KOLLAM: A local court on Thursday granted statutory bail to Unnikrishnan Potti, the prime accused in the Sabarimala gold theft cases, following which he was released from prison. Potti secured the relief in the second case related to the incident.

Kollam Vigilance Court Judge Mohit C S granted bail to Potti in the case pertaining to the theft of gold from the door frames of the Sreekoil (sanctum sanctorum).

The bail was granted as the SIT probing the case failed to file a charge sheet within 90 days of Potti's arrest, making him eligible for statutory bail.

He had earlier been granted statutory bail in the case related to the theft of gold from the Dwarapalaka (guardian deity) idol plates.

The court imposed conditions, including execution of a bond with two solvent sureties for ₹2 lakh each, a direction not to enter Pathanamthitta district, a direction to refrain from influencing witnesses or tampering with evidence, and an obligation to appear before the IO whenever summoned.

After completing bail formalities, Potti was released from the Thiruvananthapuram Special Sub Jail by around 6.30 pm. His family members received him. He is the first ac-

cused in both cases and is the fourth person arrested in connection with the incident, to be released from custody. It was Potti who had approached the Travancore Devaswom Board (TDB) for replating gold-clad artefacts. The SIT claimed that gold was diverted from the artefacts during the process.

Meanwhile, the court extended the remand of Tantri (chief priest) Kandararu Rajeevaru. He has filed a bail petition, which will be considered on February 9. The Kerala HC, which had directed the constitution of the SIT in the Sabarimala case, had expressed satisfaction over the progress of the investigation, even as some accused became eligible for bail owing to delays in filing the charge sheets. # Anna varsity teaching fellows' protest for job regularisation enters 3rd day

FOR the third consecutive day, teaching fellows working at Anna University's regional centres staged a sit-in protest inside the Madurai campus on Thursday, demanding immediate reinstatement and regularisation of their services by the Tamil Nadu government.

The teaching fellows said they were abruptly denied work after December without prior intimation. Speaking to TNE on condition of anonymity, one of the protesting teaching fellows said they have been working for over 10 years on a consolidated monthly salary ranging between ₹27,000 and ₹30,000.

"The Madras HC recently directed the state government to regularise services on par with assistant professors. However,

despite the court order, the Anna University administration has not extended our employment," the fellow said.

In total, 328 teaching fellows working at Anna University's regional centres in Madurai, Tirunelveli and Coimbatore, along with 13 constituent colleges, continued their protest.

Meanwhile, Makkal Kalvi Kootiyakkam coordinator Prof R Murali condemned the state

government's decision not to extend services of teaching fellows. "This is akin to mercy killing," he said. He urged Chief Minister MK Stalin to immediately reinstate teaching fellows and halt recruitment of teaching staff on an hourly basis.

Responding to the issue, a senior Anna University official said that the matter was purely a decision of the state government.

AMONG the key projects cleared on Thursday is that of Kaynes Circuits India Private Limited, an electronics manufacturing company producing printed circuit boards, camera modules, and laminates, marking a significant step in advanced manufacturing in TN. The project from Yeemak Group, which manufactures BLDC Motor, PCB Assembly and compressor components, also got approval.

Johnson Electric Private Limited, which manufactures actuators, BLDC motors and

power cooling motors, is another major project. Evervan-Kothari Footwear Private Limited is expected to generate employment for nearly 25,000 people. In addition, we are bringing Adidas brand footwear manufacturing to TN," Rajaa said.

Chennai Radha Engineering's investment in ship hull manufacturing was described as highly significant. Rajaa said shipbuilding was critical to advancing the blue economy and that TN's long coastline must be effectively utilised to ensure sustainable livelihoods.

The cabinet also cleared projects by Jeanvys Group (Aerospace and Defence Systems) involving the manufacture of radars, artillery shells and missile sub-systems.

Yazaki India Private Limited, engaged in automotive components and wiring harnesses, is also part of the approved investments. Further, expansion proposals of Hyundai Wia India Limited, which manufactures CVJ modules, thermal management modules and drive shaft assemblies, have been cleared.
