Introduction of Continuous Clearing and Settlement on Realisation in Cheque Truncation System (CTS)

Reserve Bank of India has instructed Banks to implement continuous clearing and settlement on realisation of cheques from October 4, 2025 vide its circular titled "Introduction of Continuous Clearing and Settlement on Realisation in Cheque Truncation System" dated August 13, 2025.

In abidance to this circular, Ujjivan Small Finance Bank is undergoing changes in Clearing Process. With reference to it, this is an intimation to maintain sufficient balance in your Saving/ Current Account maintained in our Bank before issuing cheque to avoid Cheque return from your account.

Further Positive Pay System (PPS) Confirmation is also required for cheque amount INR 5 lacs and above. Kindly utilize the Branch Channel/ Phone Banking/ Internet Banking/ Mobile Banking Platform for updating PPS on cheque issuance.
