# DON THREATENS BBC WITH \$1B Senate moves closer to ending record US govt shutdown LAWSUIT OVER EDITED SPEECH

Accuses it of twisting his 2021 poll speech; chairman apologises for 'error of judgement'

## LONDON

US President Donald Trump has threatened legal action against the BBC over the way a speech he made was edited in a documentary aired by Britain's national broadcaster.

BBC chairman Samir Shah on Monday apologised for the "error of judgement," which triggered the resignations of the BBC's top executive and its head of news. Director-General Tim Davie and news chief Deborah Turness quit on Sunday over accusations of bias and misleading editing of a speech Trump delivered on January 6, 2021, before a crowd of his supporters stormed the Capitol in Washington.

The hourlong documentary titled "Trump: A Second action." A letter from Trump

Chance?" — was broadcast as part of the BBC's "Panorama" series days before the 2024 US presidential election. It spliced

together three quotes from two sections of the 2021 speech, delivered almost an hour apart, into what appeared to be one quote in which Trump urged supporters to march with him and "fight like hell." Among the parts cut out was a section where Trump said he wanted supporters to demonstrate

peacefully. Shah said the broadcaster accepted "that the way the speech was edited did give the impression of a direct call for violent

posted a link to a Daily Telegraph story about the speechediting on his Truth Social network, thanking the newspaper "for exposing these Corrupt 'Journalists.' These are very

dishonest people who tried to step on the scales of a Presidential Election." He called that "a terrible thing for Democracy!"

In a resignation letter to staff, Davie said: "There have been some mistakes made and as director-general I have to take ultimate responsibility."

Turness said the controversy was damaging the BBC, and she quit "because the buck stops with me." She defended the organisation's journalists against allegations of bias.

"Our journalists are hardworking people who strive for impartiality, and I will stand by their journalism," she said Monday. "There is no institutional bias. Mistakes are made, but there's no institutional bias.'

## **WASHINGTON**

THE US Senate took a major step toward ending the longest government shutdown in American history when it cleared the way for a formal debate on a motion to resume funding to federal agencies.

The development represents significant progress toward ending a government shutdown that has dragged on for over 40 days, halted funding to federal programs and disrupted air travel and other essential industries. The breakthrough late on Sunday came after Republican and Democratic lawmakers reached a stopgap agreement to fund the government through January, after wrangling over healthcare subsidies, food benefits and Trump's firings of federal employees.

Following the deal the Republican-led chamber approved a procedural vote by 60 votes to



cuss the legislative measure.

It gave lawmakers a maximum of 30 more hours to conduct debate before voting on the motion, which will only need 50 votes to pass. It will still need approval from the Republican-controlled House of Representatives before it lands on President Donald Trump's desk — a process which could take days. As the news emerged, Trump told reporters when he arrived at the White House af-

HONG KONG: Vaishnavi Srinivasagopalan, a skilled Indian IT professional who has worked in both India and the US, has been looking for work in China. Beijing's new K-visa programme targeting science and technology workers could turn that dream into a reality. The K-visa rolled out by Beijing last month is part of China's widening effort to catch up with the US in the race for global talent and cutting edge technology. It coincides with uncertainties over the US's H-1B programme under tightened immigrations policies implemented by Donald Trump. "(The) K-visa for China (is) an equivalent to the H-1B for the US," said Srinivasagopalan, who is intrigued by China's working environment and culture after her father worked at a Chinese university a few years back.
